Works in Progress and Under Review

- *The Dangers of Deficits* [book project]
Trade deficits have reached dangerous new highs in the globalization era, highlighted by the massive U.S. deficit. Controversies over the importance of trade deficits have raged since the bullionists of the mercantilist era, but liberal theorists of international trade and finance are the last holdouts, contending that deficits are benign. To the contrary, this book will show that large and persistent trade deficits are theoretically and empirically associated with slow growth, financial crises of various forms, and distorted government policies that undermine social development.
- "Can Iraq Democratize? How Long Will It Take?"
Only about 30 nations have experienced an autocracy as severe and long-lasting as Iraq's. Only one has evolved subsequently into an established democracy. Nine have achieved coherent, if precarious, democracy. The average time required by these nine is about 50 years and only one has managed it in less than 25 years. Democratic prospects in Iraq, consequently, are very poor.
- "Deficits in Trade, Deficits in Development?"
While several analysts have argued that outward-oriented policies are preferable because they

promote trade expansion (which is associated with growth), they fail to note that such policies also promote trade *deficits* (which are associated with stagnation). The latter effect is stronger than the former.

- "The Great Divide in Micro-finance: Political Economy in Microcosm"
Current controversies over the most appropriate form of microfinance institutions (commercial, state, or NGO) mirror the ideological divide of political economy schools that champion the market, the state, and civil society. They can be resolved by cutting beneath the surface to reveal concerns over efficiency, sustainability, and mission drift which are not unique to any structural form.
- "Does Development and Democracy Work for Women?"
Gender inequality is a variable feature of developing political economies. Despite modernization theory's claim that it sharply diminishes with growth, new findings demonstrate that, in the absence of favorable political and social forces, the effect is modest.
