- ☐ **Complete the 2014-15 CSS/Financial Aid PROFILE®.**
 - Complete online @ <https://profileonline.collegeboard.com> (School code: 2365)
 - Note: A \$25 fee is charged for initial schools application. All subsequent school applications are \$16.
- ☐ **Complete the 2014-15 Free Application for Federal Student Aid (FAFSA).**
 - Complete online @ www.fafsa.ed.gov (available after January 1) (School code: 003289)
- ☐ **Complete and Submit the 2014-15 Lehigh University For Financial Aid Application**
 - Application can be printed from website and submitted along with copies of applicant's 2013 Federal Tax Returns.
- ☐ **Submit Parent(s) Federal Tax Returns**
 - Copy of parent(s) 2013 Federal Income Tax Return along with all accompanying schedules & W-2 forms. (NOTE: if you are an Early Decision applicant, you must also submit your parent(s) 2012 Federal Income Tax Return by the deadlines listed below.)
 - If parent(s) are not required to file a 2013 Federal Income Tax Return, indicate this on the Lehigh University Application For Financial Aid.
- ☐ **Submit Student Federal Tax Returns**
 - Copy of 2013 Federal Income Tax Return along with all accompanying schedules & W-2 forms. (NOTE: if you are an Early Decision applicant, you must also submit your parent(s) 2012 Federal Income Tax Return by the deadlines listed below.)
 - If student is not required to file a 2013 Federal Income Tax Return, indicate this on the Lehigh University Application For Financial Aid.
- ☐ **2014-15 Business/Farm Supplement (If Applicable)**
 - **Complete and submit if either parent is self-employed or an owner (part or full) of a corporation/partnership.**
 - Attach copies of the business tax returns (Schedule C, Corporate Tax Returns and/or Partnership Tax Returns).
- ☐ **2014-15 Non-Custodial Parent's Statement & Income Information (If Applicable)**
 - **Complete and submit if biological parents are not married, and custodial parent is not remarried.**
 - Attach copy of Non-Custodial Parent's 2013 Federal Income Tax Return with all accompanying W-2 forms and schedules. (NOTE: if student is an Early Decision applicant, submit non-custodial parents 2012 federal tax return by the deadlines listed below.)
