- □ Complete the 2025–2026 College Board CSS Profile™
 - Complete online at <u>cssprofile.org</u> (School code: 2365). Note: if your legal parents do not live together, both of your parents (your custodial parent and your non-custodial parent) will need to complete separate applications.
- □ Complete the 2025–2026 Free Application for Federal Student Aid (FAFSA)

Complete online at <u>studentaid.gov</u> (School code: 003289) using student and parent information. The FAFSA will be released in December 2024 instead of the normal October release date.

□ Submit parent(s)' 2023 Federal Income and Business Tax Returns
If any parent (custodial/non-custodial/step-parent) is required to file a tax return, please submit a signed copy of your 2023 federal (1040) income tax return, along with all ac-

companying schedules and W-2 forms. If any parent (custodial/non-custodial/step-parent) is or an owner (part or full) of a corporation/partnership, please also submit copies of the 2023 business tax returns (1120, 11205, 1065) and any accompanying schedule K-1s).

☐ Grant Proxy Access to Parents/Guardians/Third Parties (recommended, not required)

The Family Educational Rights and Privacy Act (FERPA) limits the kind of information that can be shared by Lehigh faculty and staff. By granting proxy access, you can give select individuals permission to view specific student information protected by FERPA (i.e, financial aid, grades, schedules, etc.). Log in to Banner via **connect.lehigh.edu** and click on "student services" to initiate proxy access set up.

The materials above are required if you are applying for institutional need-based aid. If you are applying for federal aid only, you will only neet to submit the FAFSA. If you have been selected for verification by the government then you may be required to submit additional documents, such as the Verification Worksheet.
