# **Dynamics of Learning and Development**

The processes that generate development in infants and children are much less well known than are some of the landmarks along the trajectories of that development. In this class, we will explore some of what has been written about this, though it is a remarkably small percent of the overall developmental literature, and also explore a possible model for these processes.

A related issue concerns the relationship(s) between learning and development. In some views, learning is all there is; in others, learning and development are fundamentally different processes. I will suggest a model in which learning and development are differing aspects of one underlying kind of process.
